

**General Terms and Conditions
ESOI-EORTC 2021 Workshop

The minimum age limit for registration is 18 years.
All time specifications within the ESOI registration process refer to CET (Central European Time).
ESOI accepts no responsibility for errors or misprints.

REGISTRATION

Registration for the ESOI-EORTC 2021 Workshop is to be made electronically by completing the respective registration form. Registrations without full name, complete email and postal address cannot be processed. It is the participant's own responsibility to provide all necessary details and documents and to ensure the completeness of registration.

Registration fees depend on the date your payment is received at the ESOI bank account and will be considered as incomplete and adjusted accordingly if the payment is not received by the relevant deadline. The relevant ESOI registration deadlines are announced on the ESOI website (www.esoi-society.org).

ESOI is using the secure online platform "aanmelder.nl" for online registration (<https://www.aanmelder.nl/en>). After successful registration and successful payment, a confirmation email together with a payment confirmation document will be provided.

MEMBER REGISTRATION

Reduced member registration is available for all active ESOI members as well as active EORTC members in 2021. Please note that in case your membership fee was not paid and/or due to missing documents your membership is not (yet) active, your registration as a member will not be accepted.

RESIDENT REGISTRATION (if applicable)

Reduced resident registration is available for all residents. Please send your resident proof to the ESOI Office (office@esoi-society.org). Please note that in case of missing documents, your registration as a resident will not be accepted.

STUDENT REGISTRATION (if applicable)

Reduced student registration is available for all student. Please send your student proof to the ESOI Office (office@esoi-society.org). Please note that in case of missing documents, your registration as a student will not be accepted.

REGISTRATION OF THIRD PERSONS

Upon registration on behalf of third persons, the registering person warrants and guarantees to be entitled to execute such registration according to these Terms and Conditions in the name and on behalf of such third persons by proxy and to declare any and all approvals and consents required according to these Terms and Conditions in the third person's name and behalf.

PAYMENT

Payment of the registration fee can be made by credit card (VISA or MasterCard) only. No other payment method will be accepted. Upon receipt of the payment, a payment confirmation will be issued and sent via email.

CANCELLATION POLICY FOR PARTICIPANTS

A cancellation more than 4 weeks prior to the event date will result in a refund of paid registration less an administration fee of Euro 100.00. In case of cancellation less than 4 weeks prior to the event will not result in any refund of registration fees paid.

CANCELLATION, POSTPONEMENT, RELOCATION

In the event that it is judged advisable or necessary to have the ESOI-EORTC 2021 Workshop cancelled, postponed, to have the location changed or to have the ESOI-EORTC 2021 Workshop closed early due to events beyond the control of ESOI - European Society of Oncologic Imaging (e.g. cancellation of flights, strikes, natural disasters, epidemics, travel bans, official orders, closure of the event centre, etc.) ESOI shall not be obliged to any refunds.

In such event, the obligation of ESOI shall be restricted to take reasonable efforts to relocate and/or to postpone the ESOI-EORTC 2021 Workshop for not more than seven months from the original finish date. In the event of a relocation and/or postponement of the ESOI-EORTC 2021 Workshop, the contract partner of ESOI shall remain entitled to participate at the ESOI-EORTC 2021 Workshop at the new date and/or the new site under the same terms and conditions. In such event, ESOI will not be liable for any damage or loss incurred by their contract partner.

If, for any reason, it becomes impossible to hold the ESOI-EORTC 2021 Workshop within the deadline of seven months, ESOI will refund to the contract partner the sum paid, deducting the price for services still available (eg. online participation) and the expenses already incurred in preparations of the ESOI-EORTC 2021 Workshop on a pro rate base according to the percentage determined and disclosed by ESOI.

If necessary or possible ESOI may decide to offer the ESOI-EORTC 2021 Workshop as an online event using the same structure and offering the same conditions. In such case all registrations will be moved to the online event and registered participants offered access to the online event. The fact to stage the event as an online event will not result in any refund of registration fees paid.

NAME CHANGE

Name changes will be treated like the cancellation of one registration and the new registration of another participant. New registration and payment are required.

PERSONAL DATA

Participants are entitled to revoke their consent to the specific data processing at any time by contacting the ESOI Office.

DOCUMENTS

A confirmation of attendance will be made available to the participants after the online course. Documents such as the confirmation of attendance will be saved and may be provided for a maximum of three years only. Confirmation of payments will be saved and may be provided for a maximum of seven years.

LIMITATION OF LIABILITY

There is neither any liability nor any obligation of ESOI in case of cancellation of an ESOI course for whatever reasons. Apart from damages caused by physical injury, the liability of ESOI for damages of any other kind shall be restricted to wilful intent or gross negligence. ESOI shall not be liable for any damages caused by force majeure.

PLACE OF PERFORMANCE/APPLICABLE LAW/PLACE OF JURISDICTION

The place of performance of any duties and obligations for ESOI and the participant sides shall be Vienna. Place of jurisdiction shall be 1010 Vienna, Austria. ESOI shall also be entitled to pursue any claim before the courts of law competent for the defendant's domicile or general residence. Any contractual relationship with the ESOI shall be subject to Austrian law.
